Directions for the applicant:

1. To be eligible, you must:
 - (a) Be a high school senior
 - (b) Be the son, daughter, niece, nephew or grandchild of a Consolidated Auto Sales customer.
 - (c) Possess an excellent high school record of academic achievement measured by your performance in valid secondary school courses including English, Mathematics, Science, Social Studies, and other electives with a **GPA of 3.0** or higher. **Attach copy of high school transcript.**
 - (d) Demonstrate an aptitude for college work measured by performance on college entrance exams, such as the Scholastic Aptitude Test (SAT) and/or the ACT. **Attach copy of scores.**
 - (e) Demonstrate an involvement in your community by community service. Community service must be validated by either documentation from a church; other community service organizations, i.e. Boy/Girl Scouts, Key Club, United Way, Boys/Girls clubs, YMCA; service clubs within school; **or** preferably a **Service Learning Seal** to be reflected on high school diploma.
 - (f) **Student essay** stating career goals, attributes that the student possess that he/she feels will lead to success, who and/or what led them to this career, and what part did community services play in high school and career choice. Essay must have correct grammar, spelling, punctuation and be coherent.
 - (g) Letters of recommendation (maximum of 5) from high school principal, teacher, or community leader.
 - (h) A recent photo must be submitted 3"x5" or larger.

2. You are to complete this form and return it to the offices of Consolidated Auto Sales, Inc., 1610 E. Van Buren, Phoenix, AZ, 85006. All information supplied by you is for use of the Selection Committee of Consolidated Auto Sales and will be treated as confidential.

3. Be sure that you have filed an application for admission to the accredited college(s) of your choice and be certain to arrange for and take the College Entrance Examination Board Scholastic Aptitude Test and other appropriate entrance examinations which may be required by each institution to which you seek admission. It is the nominee's responsibility to make all arrangements for college admission.

4. **Application deadline May 5, 2012.** Scholarship recipients will be announced in **May 19, 2012.** The scholarship will be funded upon notification of enrollment by the college to Consolidated Auto Sales. Notification must be within 60 days of receipt of scholarship or scholarship will be awarded to next qualified recipient.
